Winter 2010 registration is now open! For all BSW seniors and MSW Advanced year, don't forget to apply for Graduation by February 5, 2010 through Pipeline. MSW/BSW students should file for degree during the priority registration period. Applications for graduation must be filed through pipeline under 'Student Record - apply for degree' with a fee of \$40.00. **Please make certain you file for degree for the correct term. If you are completing degree requirements in May 2010, the term is Winter term 2010.** You must apply and pay again if you do not meet requirements in the term of application. You will not graduate if you do not apply!!

Registration Error Message Procedures:

If you receive an error message (ie. Prereq. and test score error, closed course) please call ([313\) 577-4409](tel:3135774409) to report the message. Be prepared to provide the following information: Full Name, 9 digit ID#, Course Number, CRN#, Registration error notice, Student Status, Daytime Phone# and WSU e-mail#. We will then review your report to assess and evaluate the error/over-ride request and will notify you by phone or e-mail regarding the outcome and if an over ride can be issued and indicate to you if you can then register for the course. Please note that you must call to report this error. No e-mails will be accepted. We also ask for your patience as we take time to fully explore your request. Closed over rides for entry to the field seminar courses S W 7772 or 8882 are limited as we try to keep enrollment low. Please try to register for an open section.
