Accelerating the reach and impact of mental health services for justice-involved individuals: The Michigan Mental Health and Justice Center

This application develops an Advanced Laboratory for Accelerating the Reach and Impact of Treatments for Youth and Adults with Mental Illness (ALACRITY) P50 Research Center. Located in Michigan, the goal of the Michigan Mental Health and Justice Center is to accelerate the pace of transdisciplinary research to solve systemic barriers to adequate mental health care and service linkage for justice-involved individuals with mental illness nationally, especially those with serious mental illness (SMI) and those at risk for suicide. With significant near-term impact, this work has the potential to reduce morbidity, mortality, and suffering due to mental health conditions for millions of the U.S.’s most vulnerable.

Michigan Mental Health and Justice Center Project 1: Using data linkage to find and intervene with individuals with mental illness in jails and courts

This project evaluates the accuracy, feasibility, acceptability, uptake, and utility of a real-time data linkage platform to provide notification to community mental health clinicians when their clients are booked into or released from jail or receive a pending court date, along with clinician instructions for how to promote service linkage. Better coordination of care between jails/courts and community mental health can reduce psychiatric decompensation following arrest,

reduce preventable suicide and medication-related deaths, and increase compliance with court-ordered conditions (including orders to appear), lessening additional justice involvement.
